

## **CAN ANTHRAX HEIGHTEN RISK OF DENTAL DECAY?**

In 1998 President Clinton signed a bill allowing the Pentagon to experiment with the Anthrax Bacillus on our military. The government was concerned that our enemies were developing chemical warfare using this organism and wanted an immunization vaccine.

A company named MBPI, Michigan Biologic Products Institute, located in Michigan, was the only American Manufacturer of an Anthrax vaccine, not FDA approved, but used in the farming industry to possibly help those exposed to the anthrax bacillus that was found in animal hides. This order could not be met, MBPI had lost millions a year for several years when, in 1996, it decided to sell. No one was seriously interested in buying the outdated plant and no large markets for Anthrax existed.

The plant was purchased in 1998 by Admiral William Crowe Jr., former Chairman of the Joint Chiefs of Staff and the previous Ambassador to Britain along with Fuad el-Hibri, a German of Sunni Lebanese descent. They made this purchase when it was rumored that the Clinton Administration was threatening war with Iraq, a country to whom the United States had previously sold live Anthrax Bacillus in hopes that Iraq would use it against Iran. It was evident that the United States would need an Anthrax vaccine as Iraq now had the capability of using Anthrax in chemical warfare against the United States.

After the purchase of MBPI the name was changed to BioPort and the company was closed for renovation for two years. It had numerous problems as stated by the FDA and could not get FDA approval. These included potency consistency, vaccine contamination, unsterile production practices, record keeping, equipment maintenance, safety violations, scientific procedures etc. These violations prevented the plant from manufacturing fresh supplies for three years. On top of it being an old, out-dated building it also had an insufficient filtration process and contaminated vaccines sitting in old refrigerators left by MBPI.

However, upon purchasing MBPI the government awarded BioPort a \$29 million contract to “manufacture, test, bottle and store the anthrax vaccine”. Admiral Crowe denied he knew of the Pentagon’s intent to develop a vaccine before purchasing MBPI. His share was 17%.

The U.S., government gave BioPort over 20 million dollars to aid in the renovation of this plant as it wanted to immunize our troops prior to deployment in 2002. BioPort was then given orders for 600,000 doses, charging \$20 a dose, which they could not meet. However, it is believed the refrigeration had been turned off during renovation and was, again, turned on. Not only was this old vaccine now outdated, it was contaminated by lack of refrigeration. There sat thousands of vials of old vaccine. The Pentagon gave permission to BioPort to ship these vials between March of 1998 and January of 2000 as it was panicking about being able to produce new vaccine. According to the Pentagon, 2.1 million doses of stockpiled, pre-February 1998 vaccines were administered to

535,000 troops. The conclusion as to the condition of these vials at this point is up to you. **In August of 2000 the FDA prohibited BioPort from using any pre-1998 vaccines and in 2012 the Anthrax vaccine was discontinued.**

Hundreds, if not thousands, of American soldiers have suffered serious reactions after receiving the mandatory Anthrax vaccine. Permission to receive the vaccine was not secured from the soldiers and many were not aware of the type of vaccine they were receiving. Thousands of doses were administered without proper recording in medical records. Several batches of this vaccine that were still available for testing have been found to be contaminated. Cases involving serious memory loss, muscle weakness replicating M.S., digestive problems resulting with severe abdominal pain and vomiting with each meal, seizures 5-10 times a day, and even death have been reported.

The U.S. asked brave Americans, both Reserve, National Guard, and enlisted troops, to serve in dangerous environments such as Iraq and Afghanistan, be exposed to biological and chemical agents, experimental vaccines, and environmental toxins ranging from by products of air pollutants from the burn pits, depleted uranium, and burning oil wells.

There has been no report of the anthrax vaccine being the causative agent of dental decay, but there has never been a tooth tested to determine if this is true. RAW has contacted the following Level III laboratories around the world requesting the testing of extracted, decayed teeth from our veterans suffering full mouth dental decay:

RAW located Dr. Beadle in Dallas who volunteered to provide full extractions and dentures for Brad. Because of Dr. Beadle's generosity, I mailed a Press Release to Dallas media. Byron Harris, an investigative reporter with WFAA, produced a two part documentary on this problem. It aired in February of 2012 and within 48 hours an additional 19 veterans in the Dallas area contacted RAW with the same symptoms.

RAW has written every Congressman and Senator regarding this problem, no responses were ever received. I refer to this dental problem as the "Agent Orange" of Iraq. Our veterans are suffering life altering conditions and unless considered 100% disabled, there is no dental provided. It is also a fact that when an **enlisted** veteran receiving 100% disability calls the VA Dental Dept. for an appointment, it takes months for a thirty minute appointment to be scheduled. They will see a different dentist at each appointment who must review the treatment record, administer the lidocaine, and by the time it takes effect, there are fifteen minutes remaining for treatment. It would take many years to receive the required restoration.

**PLEASE SUPPORT RAW IN CONTINUING TO PROVIDE BOTH SOFT TISSUE AND DENTAL RESTORATION TO OUR VETERANS AS WELL AS CONTINUE ITS EFFORTS TO REQUIRE THE U.S. GOVERNMENT TO FURTHER RESEARCH ITS RESPONSIBILITY FOR THE DENTAL DECAY BEING SUFFERED BY VETERANS AND ACTIVE SOLDIERS WHO RECEIVED THE ANTHRAX BACILLUS VACCINE WITHOUT THE SOLDIERS WRITTEN CONSENT.**
